8. Reports from the Executive:

a. Co-Administrative Coordinator's Report

Prepared for the Music United Annual General Meeting (AGM) by Debbie Fingas and Brenda McLay April 23, 2022

We are grateful and say thank you to the many passionate volunteers and members of Music United who continued to provide a strong and supportive presence over the past year. Your time and dedication, in guidance with the Holy Spirit, has truly been a blessing to the wider church community.

Several years ago, the Music United Team embarked on a journey to develop a more relevant governance structure. After much consideration and discussion, a model was adopted last April based on a smaller administrative team as well as a separate Convenor Team. The idea of this was to allow Convenors more time to develop initiatives for their own regions while the administrative team could deal with national development of the organization and see to some of the more routine tasks.

The model also included the adoption of a co-chair position for the administrative team for the past year. At this AGM, one person was to drop off the executive and the other person continue. However, the co-application has proven to be a valuable addition and this position will continue as a co-position with chairs ending their respective terms at staggered intervals to allow for continuity within the organization.

The model of the two groups, convenor and administrative, has also worked well which the administrative team and convenor coordinator will expand on further in their respective reports. In January, the administrative team joined the convenor meeting allowing for a meet and greet as well as a broader discussion. We encourage this practice to continue possibly allowing for up to 3 to 4 joint meetings per year; the AGM being one of those meetings.

At the last AGM, there was discussion on the United Church Musician Handbook and the association was charged with providing recommendations regarding its broader presentation to the church community. Fred Graham will be addressing the outcome of his research into this topic and we thank him for his time and diligence in this exercise.

It has been a privilege and a pleasure to serve the association as your Co-Chairs. At this meeting, Brenda McLay will be retiring from the Music United team after a decade of assisting in various capacities however she continues as a member and offers her support to this most necessary and worthwhile organization. Debbie Fingas will continue in the position of Co-Chair for a further term of 2 years and looks forward to being part of the exciting future contributions of the Music United Association.

While the past 2 years of pandemic life have been difficult and to the extreme for some, and while the world's heart reels from the confusion and sadness of so many conflicts and atrocities, the one constant we continue to see rising globally, is our connection in music. With its ability to make us family, to lend compassion and its ability to heal, music is a force like no other. Supporting those engaged in music, and to the greater glory of God, brings out the best of our humanity and is time well spent.

c. Communication Report – Bruce Harding

Another pandemic year has passed, and despite the continuing turmoil and uncertainty, our Music United community has continued to grow, and our members have faithfully continued to serve congregations across Canada. Thank you for all you do for music in The United Church of Canada!

Our Facebook group has flourished over the past year, growing to our current level of over 1100 members! Many thanks to all who check in regularly and actively participate. I have been thrilled to see the community increasingly resourcing each other - bringing newcomers up to speed when they join the group, even when the questions they post have been asked and answered repeatedly. Questions regarding streaming and copyright, employment issues, sharing new repertoire and suggesting appropriate music for various occasions in the church year continue to be conversational priorities. Facebook has changed the structure and process for groups such as ours in recent months, and this has affected how we operate - now anyone can join a group without approval, but the moderator must approve them before they can post a question or response. Despite the structural changes, a Facebook group is still our best option, since it allows for two-way conversation, as opposed to a Facebook page, which functions like a website.

Speaking of websites, <u>www.musicunited.ca</u>, continues to be a strong point for first contact with new members and for job postings and employment information. A steady stream of enquiries flow through to me as moderator. If you need to reach someone, a regional convenor or admin team member, continue to use the contact forms on the site and I will redirect your communication to the appropriate person. And if you have suggestions for the website, or something you think needs to be posted such as an event notice, send them to us and we will assist in spreading the word.

One our biggest functions at Music United has been to provide resources and assistance regarding employment issues - we continue to vet potential job postings to ensure there are adequate hours and compensation for the work expected, following the guidelines in our handbook, *The Ministry of Music in The United Church of Canada*, available as a free download at https://united-church.ca/sites/default/files/2021-04/ministry-of-music_apr2021.pdf. The past year has seen many transitions in congregations across the country, so the opportunity to educate and provide support has been critical - in some cases, congregations have revised their expectations and remuneration when searching for new music personnel, so I continue to be grateful for our collective advocacy in this area.

To close, I will repeat myself from previous years: I can't stress enough how important it is that we all keep in touch and up to date by visiting our website and participating in our Facebook group. When we do so, we demonstrate our commitment to Music United and we support each other in the important work we do in communities large and small. You may have just the right answer for someone's question, or a question you ask may spark helpful conversation with others. We're in this together!

d. Program Chair – Dawn Duncliffe

I would like to start this report by giving a huge "Thank you!" to everyone for the warm welcome I have received as one of the new members of the Music United Executive. It has been (and still is!) greatly appreciated!

This year has been an exercise in adaptation and change. I started out in September with most of Music Matters 2022 ready to go - thank you to Jason Locke for keeping everyone from 2020 "on hold" - and a few meetings and discussions led to even more ideas of sessions to develop and share. Then, the COVID numbers over December and January made us take a good look at whether we could, in good faith, ask people to commit to an in-person event that might not be able to happen. We made the decision to offer an online

Music Matters for 2022 in order to allow for everyone to be able to plan ahead for April. This change did necessitate a return to the drawing board for planning and a request – yet again – to put some of our presenters on hold one more year while reaching out to some others, like Jane Best, who are working on projects to help us through these uncertain times. Our host venues have also shown great willingness to adapt as we have rescheduled.

I look forward to continuing my work as program chair and hope to be able to meet more of you in person at Islington United in April 2023 and then again in Thunder Bay in April of 2024. I welcome any ideas that people may have for professional development sessions and encourage you to send me a message through email or through our Facebook group.

e. Membership Chair – Josh Zentner-Barrett

This year was the first full year of the Membership Coordinator in the Music United executive. This position oversaw three main tasks: continued submissions of the Music United column in *Gathering*, the creation of a database of Music United members, and the development and distribution of a Music United newsletter.

The Music United column in *Gathering* usually features the reflections of one (or more) Music United members on the assigned topic. This year included topics such as music and racism, Forest Church, and pandemic learnings. I attempt to find columnists from across the country, representing different sizes and styles of churches. Our varied columns were well-received by readers, and continue to showcase the resources available to Music United members. One of our columns, by retired professor of music education Deb Bradley, led to a webinar in partnership with United-in-Learning on music ministry and racism.

We launched a database of Music United members in December 2021 using Mailchimp

as our platform. Through regular posts in the Facebook group, we invited members to sign up to receive occasional emails from the association. By March 2022, we had almost 100 people registered, and we expect more to come.

Finally, March 2022 also saw the distribution of our first Music United newsletter. Drawing on our database, this newsletter will go out to members three times per year: March, June, and November. Our first issue featured information about Music Matters 2022, a member profile, a link to a webinar led by one of our members, as well as a reminder about the Oxford Fund. Upcoming issues will aim to be just as brief, including a member profile, links to resources, and information about upcoming events. Feedback on the newsletter is always appreciated.

It will be helpful for our Convenors to encourage members to sign-up to the database as we go forward. In addition, I invite Convenors to identify members who might be able to offer a column for an upcoming edition of *Gathering*. We love lifting up the voices of our members!

In the meantime, it is helpful for members and for convenors to connect with the Membership Coordinator in order to build the membership list.
