MEMBERSHIP REPORT

The membership coordinator oversees the membership database, putting together communication via newsletter through MailChimp and coordinating Music United content creation for the Gathering publication.

Similar to last year, the membership is slowly growing. We keep our membership list through a free MailChimp account, where we distribute the Music United newsletter. We continue to use the Music United Facebook page as a platform to promote members to join the newsletter mailing list, and repost announcements from the newsletter on the page. Both Mailchimp and Facebook are effective in communicating with our broader network. Our mailing list currently has 112 members.

We send out newsletters throughout year, the frequency is assessed to be on an as needed basis depending on promotional needs for upcoming events, i.e. Music Matters. The newsletter

usually features a brief introduction, details and links to upcoming events and resources, and on occasion a profile of a Music United member. If you have an experience, a song, a resource, event or workshop to promote and share, please consider submitting to the Music United newsletter!

The role of Membership Coordinator also coordinates Music United column to Gathering Magazine. The Music United column is prepared by one (or more)Music United members. The article usually features reflections on the assigned topic by the editor, or can feature that is seasonally relevant subject, worship ideas, prayers and musical resources. We have two written contributions from Byron Herman, who wrote on the topic of Hymn Preparation, and Rev. Dr. Lisa Waites prepared a theological reflective piece around the history of our hymnody while facing the 100th anniversary as the United Church.

Looking onward to 2024-2025, we will continue to promote and encourage more of the Music United network to join our membership list to have a more direct communication for upcoming Music United news, events & opportunities.

COMMUNICATIONS REPORT

Life in the post-pandemic era continued to unfold in 2023 for United Church musicians across the country. In my own ministry context at Crossroads United Church in Delta, BC, there is excitement and hesitancy all rolled in together with a greatly altered sense of expectation – people approach life differently after many months of lockdown and anxiousness. But it sure is good to be singing in community again!

Our Music United Facebook group, <u>https://www.facebook.com/groups/musicucc</u>, has grown from roughly 1250 members last year to over 1330 members currently. Conversation continues to be stimulating and helpful, with resources being shared, questions being asked and answered, and new music being released to the community. Two new options which Facebook is offering are group chats on topics of our choice – we will likely begin exploring the possibilities this year – and the ability to post anonymously, which provides a greater degree of safety for members when they need to post sensitive questions. Thanks to all who actively participate and help keep our group vital and important to the work of Music United.

Our website, <u>www.musicunited.ca</u>, continues to attract new enquiries and to provide documents, job postings and event notices to the community. We continue to vet potential job postings to ensure there are adequate hours and compensation for the work expected, following the guidelines in our handbook, *The Ministry of Music in The United Church of Canada*, available as a free download at <u>https://united-church.ca/sites/default/files/2021-04/ministry-of-music_apr2021.pdf</u>. In some cases, congregations have revised their expectations and remuneration when searching for new music personnel, so I continue to be grateful for our collective advocacy in this area. If you need to reach someone, a regional convenor or admin team member, continue to use the contact forms on the site and I will redirect your

communication to the appropriate person. And if you have suggestions for the website, or something you think needs to be posted such as an event notice, send them to us and we will assist in spreading the word.

To close, this great, volunteer network of musicians and music lovers from across the church continues to inspire me! We are at our best when we're all actively engaged, so thank you for all you do to keep our community thriving.
